## 2 1.1. On the template

This is an English-language template for Microsoft Word based on the style guide of *Gengo Kenkyu*.

4 It is requested to use this template when preparing a manuscript to be submitted to the journal.

This template is supposed to be used without modification to the present layout settings such as

## 9 1.2. How to use the template

This template uses Microsoft Word's systematic Styles feature. The built-in styles (Ribbon > Home

> Styles) cover most of the fundamental elements of a linguistic manuscript such as section headings,

12 minimizing the need for ad-hoc text styling. For example, the Strong style gives **bold sans-serif** font.

13 Note that this does not rule out individual font styling by way of the Font feature.

14 Similarly, the styles labeled as Headings 1–5 give automatically numbered section titles (1, 1.1,

15 1.1.1, ...). This makes the structure of the manuscript readable for the dynamic outline features of

16 Microsoft Word such as Outline View and Cross-reference. Note again that this is not meant to  
17 discourage the authors from numbering section titles manually.

19 **1.3. Length and font size**

20 This template is intended to conform to the style guide, which states that the word count of a  
21 manuscript in the Roman alphabet should be around 350 words per page. The template's layout settings  
22 such as font size and character/line spacing should not be modified either in the body text or in the  
23 references/abstracts/notes.

24 According to the style guide, the maximum number of pages is the following: 40 pages for a  
25 research paper, 15 pages for forum, 20 pages for a review article, 10 pages for a book review. These  
26 page counts include all figures, tables, references, abstracts, and notes.

27 The text in the Roman alphabet should be in Times New Roman, 11 points. Smaller fonts should  
28 not be used in any part of the manuscript.

30 **1.4. Notes and citations**

31 **1.4.1. Notes**

32 Notes should appear at the end of the text.<sup>1</sup> To put a note using Microsoft Word's built-in endnote  
33 feature, select Ribbon > References > Insert Endnote.<sup>2</sup> It is also possible to insert subscripted note  
34 numbers and endnote texts manually.<sup>3</sup>

36 **1.4.2. Citations**

37 All the materials mentioned in the manuscript should be listed in the bibliography. The reference

38 list should not include any uncited material. Citations should be made in the body text whenever  
39 possible; avoid putting a note only for the purpose of citation.

40 See the style guide for the format of the references; as examples, this template cites Sakuma (1941)  
41 and Postal (1970) as journal articles, Kindaichi (1955) and Kiparsky (1968) as articles in collections,  
42 Bickel et al. (2015) and LSJ (2017) as online resources, respectively.

44 **1.5. Linguistic examples**

45 See the style guide for the formatting of linguistic examples. Although this template includes a  
46 built-in style for numbered examples, it may not be very helpful because it does not provide any  
47 automatic styling.

48 The following glossed examples follow Leipzig Glossing Rules (Bickel et al. 2015). Abbreviations  
49 in the glosses should be defined separately, typically in a note<sup>4</sup> or after the body text.

67 and figures remain readable in the printed version.


